## RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this "Release") is made as of this 1st day of November, 2019, by CIBC BANK USA f/k/a The PrivateBank and Trust Company (the "Secured Party") in favor of EDCO Health Information Solutions Inc., a Missouri corporation, successor in interest to Edco Group, Inc. ("Grantor").

WHEREAS, Grantor and the Secured Party have entered into that certain Loan and Security Agreement dated as of May 13, 2013 (together with any amendments, modifications or supplements thereto, the "Loan Agreement");

WHEREAS, in accordance with the terms of the Loan Agreement, Grantor and the Secured Party entered into that certain Trademark Security Agreement dated as of May 13, 2013 (the "Trademark Security Agreement" and together with the Loan Agreement, the "Security Agreements") which Trademark Security Agreement was recorded at the United States Patent and Trademark Office at Reel 5026/Frame 0595 on May 13, 2013;

WHEREAS, in accordance with the terms of the Security Agreements, Grantor pledged and granted to Secured Party, a security interest in and to all of the right, title and interest of Grantor in, to and under the Trademark Collateral (as defined below); and

WHEREAS, Grantor has requested that Secured Party enter into this Release in order to accomplish and evidence the release and reassignment of any and all right, title and interest the Secured Party may have in the Trademark Collateral pursuant to the Security Agreements.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby states as follows:

1. Trademark Collateral. As used herein, the term "Trademark Collateral" shall mean: (a) the trademarks, registrations and applications set forth on Schedule A attached hereto (the "Trademarks"), together with the goodwill connected with the use of and symbolized thereby and all extensions and renewals thereof; (b) any license agreement related to the Trademarks, together with all goodwill associated therewith; and (c) all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future infringement of any Trademark.

2. Release of Security Interest in the Trademark Collateral. Secured Party, on behalf of itself and its successors, legal representatives and assigns, hereby unconditionally and expressly releases, terminates, discharges and extinguishes, without any reservation, and reassigns to Grantor any and all right, title and interest in, to and under the Trademark Collateral, including any and all security interests, liens, pledges, charges and other encumbrances of any kind thereon.

3. Further Assurances. At the cost of Grantor, Secured Party hereby agrees to execute, acknowledge and deliver to Grantor any and all further documents or instruments and do any and all further acts which the Grantor (or its respective agents, designees or assignees) reasonably


request in order to confirm, effectuate or record this Release and Grantor's (or its assignees') right, title and interest in and to the Trademark Collateral.

4. Miscellaneous. This Release (a) shall be governed by and shall be construed and enforced in accordance with, the laws of the United States and the State of Illinois, without giving effect to any choice or conflict of law provision or rule, (b) sets forth the entire agreement among the parties relating to the subject matter pertaining hereto, and no term or provision hereof may be amended, changed, waived, discharged or terminated, except in writing signed by each party, (c) shall be binding upon the Secured Party's legal representatives, successors and assigns, and (d) may be executed in any number of counterparts, and telecopied signatures (or signatures delivered via electronic mail or "pdf") shall be enforceable as originals.
