ASSIGNMENT AND ASSUMPTION AGREEMENT
(INTELLECTUAL PROPERTY)

THIS ASSIGNMENT AND ASSUMPTION AGREEMENT (this "Assignment") is entered into as of December 31, 2012, by and between TRIARCO INDUSTRIES, INC., a Delaware corporation (the "Company"), REED COMPANY, L.L.C., a New Jersey limited liability company (the "Subsidiary" and, collectively with the Company, the "Assignors") and INNOPHOS ACQUISITION, LLC, a Delaware limited liability company ("Assignee"). Capitalized terms used but not otherwise defined herein shall have the respective meanings set forth in that certain Asset Purchase Agreement dated December 31, 2012 (the "Asset Purchase Agreement"), by and among Assignee, as Purchaser, Innophos, Inc., a Delaware corporation (the "Purchaser Parent" and, together with Assignee, the "Purchaser Parties"), Assignors, as Seller Parties, and RODGER R. ROHDE, SR., RODGER R. ROHDE, JR., and CHRISTOPHER J. ROHDE.

WITNESSETH

WHEREAS, Assignors and Assignee have entered into the Asset Purchase Agreement, the Closing with respect to which is taking place concurrently herewith; and

WHEREAS, under the Asset Purchase Agreement, Assignors have agreed to sell, transfer, convey, deliver and assign to Assignee, and Assignee has agreed to purchase and accept all of Assignors' right, title and interest in and to the Company Intellectual Property set forth on Exhibit A attached hereto.

NOW, THEREFORE, effective as of the Closing, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignors and Assignee, intending legally to be bound, agree as follows:

1. Assignors hereby sell, transfer, convey, deliver and assign unto Assignee and Assignee hereby acquires and accepts all of Assignors' right, title and interest in and to the Company Intellectual Property, together with goodwill associated therewith, all rights to sue for past, present and future infringements of the Company Intellectual Property throughout the world.

2. Assignors hereby covenant and agree that Assignors will, at any time and from time to time, upon written request therefor, execute and deliver to Assignee or Assignee's successors, nominees and assigns all such further documents and do such other acts as may reasonably be necessary and proper to perfect the transfer of Company Intellectual Property rights being transferred, and to vest the full title thereto in Assignee or its successors, nominees or assigns.

3. This Assignment shall be binding upon, and inure to the benefit of, Assignors, Assignee and their respective successors and assigns.

4. Assignors, by their execution of this Assignment, and Assignee, by its acceptance of this Assignment, each hereby acknowledges and agrees that (i) nothing contained herein shall in any way supersede, modify, replace, amend, change, rescind, waive, exceed, expand, enlarge or in any way affect any of the representations, warranties, covenants, agreements, rights, remedies and obligations of Assignors or Assignee set forth in, or any of the other terms and conditions of, the Asset Purchase Agreement; and (ii) the representations, warranties, covenants, agreements, rights, remedies and obligations of Assignors and Assignee set forth in, and the other terms and conditions of, the Asset Purchase Agreement shall, to the extent provided in the Asset Purchase Agreement, survive the execution and delivery of this Assignment and the consummation of the transactions contemplated hereby and by the Asset Purchase Agreement. No claims for indemnification shall be made under this Assignment; all claims for indemnification shall be made only pursuant to the Asset Purchase Agreement, and only to the extent permitted thereunder.

5. This Assignment shall be governed by and construed in accordance with the laws of the State of New York without giving effect to principles of conflict of laws.

6. All Actions arising out of or relating to this Assignment shall be heard and determined exclusively in any New York federal court sitting in the Borough of Manhattan of The City of New York; provided, however, that if such federal court does not have jurisdiction over such Action, such Action shall be heard and determined exclusively in any New York state court sitting in the Borough of Manhattan of The City of New York. Consistent with the preceding sentence, the parties hereto hereby (a) submit to the exclusive jurisdiction of any federal or state court sitting in the Borough of Manhattan of The City of New York for the purpose of any Action arising out of or relating to this Assignment brought by any party hereto and (b) irrevocably waive, and agree not to assert by way of motion, defense, or otherwise, in any such Action, any claim that it is not subject personally to the jurisdiction of the above-named courts, that its property is exempt or immune from attachment or execution, that the Action is brought in an inconvenient forum, that the venue of the Action is improper, or that this Assignment or the transactions contemplated by this Assignment may not be enforced in or by any of the above-named courts.

7. EACH OF THE PARTIES HERETO HEREBY WAIVES TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW ANY RIGHT IT MAY HAVE TO A TRIAL BY JURY WITH RESPECT TO ANY LITIGATION DIRECTLY OR INDIRECTLY ARISING OUT OF, UNDER OR IN CONNECTION WITH THIS ASSIGNMENT OR THE TRANSACTIONS CONTEMPLATED BY THIS ASSIGNMENT. EACH OF THE PARTIES HERETO HEREBY (A) CERTIFIES THAT NO REPRESENTATIVE, AGENT OR ATTORNEY OF THE OTHER PARTY HAS REPRESENTED, EXPRESSLY OR OTHERWISE, THAT SUCH OTHER PARTY WOULD NOT, IN THE EVENT OF LITIGATION, SEEK TO ENFORCE THE FOREGOING WAIVER AND (B) ACKNOWLEDGES THAT IT HAS BEEN INDUCED TO ENTER INTO THIS ASSIGNMENT AND THE TRANSACTIONS CONTEMPLATED BY THIS ASSIGNMENT, AS APPLICABLE, BY, AMONG OTHER THINGS, THE MUTUAL WAIVERS AND CERTIFICATIONS IN THIS SECTION 7.

8. This Assignment, the Asset Purchase Agreement, the Ancillary Agreements and the Confidentiality Agreement constitute the entire agreement of the parties hereto with respect to the subject matter hereof and thereof and supersede all prior agreements and undertakings, both written and oral, between the Purchaser Parties and the Seller Parties with respect to the subject matter hereof and thereof. In the event that the terms of this Assignment conflict with the terms of the Asset Purchase Agreement, the Asset Purchase Agreement shall control. This Assignment may not be assigned by operation of law or otherwise without the express written consent of the parties hereto (which consent may be granted or withheld in the sole discretion of each party), provided, however, that any Purchaser Party may transfer any of its rights hereunder to any of its Affiliates that is directly or indirectly wholly-owned by Innophos Holdings, Inc., provided, further, that such Purchaser Party will remain liable for all of its obligations hereunder. This Assignment shall be binding upon and inure solely to the benefit of the parties hereto and their respective successors and permitted assigns and nothing herein, express or implied, is intended to or shall confer upon any other Person any legal or equitable right, benefit of remedy of any nature whatsoever, including any rights of employment for any specified period, under or by reason of this Assignment.






