## TRADEMARK ASSIGNMENT

1. Assignor hereby assigns, conveys, transfers and relinquishes to Assignee all of Assignor's right, title and interest in and to the Mark, together with any goodwill associated therewith.

2. Assignee hereby acknowledges that upon its execution of this Assignment, Assignee will have received and be entitled to all of Assignor's right, title and interest in and to the Mark, together with any goodwill associated therewith.

3. This Assignment shall be binding upon and operate to the benefit of the heirs, successors, affiliates, associates, assigns and related parties of the parties to this Assignment.

4. This Assignment may be executed in two or more counterparts, each of which, when taken together, shall constitute one and the same instrument.

5. Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment will be governed, construed, and enforced in accordance with the laws of the State of Florida. The exclusive forum for any disputes under this Assignment will be the state or the federal courts located in Duval County, Florida.
