## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the “Release”) is made as of November 20, 2019, by ALLY BANK, as agent (in such capacity, together with its successors and permitted assigns in such capacity, “Agent”) for the Lenders (as defined in the Security Agreement defined below). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

### **W I T N E S S E T H:**

WHEREAS, Benchmark Rehabilitation Partners, LLC, SERC Rehabilitation Partners, LLC, Preferred Therapy Providers, Inc. and Physical Therapy and Hand Specialists, LLC (each, a “Grantor” and collectively, “Grantors”) and Agent are parties to that certain Trademark Security Agreement dated as of December 15, 2015 (as amended, restated, supplemented or otherwise modified, the “Security Agreement”) pursuant to which Grantors granted to Agent a lien on and security interest in, to and under the Trademark Collateral (as defined below) as security for certain obligations owing by Grantors to Agent;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on December 21, 2015, at Reel 5704, Frame 0001;

WHEREAS, Grantors have requested that Agent release its lien in the Trademarks and Trademark Collateral and reassign any and all rights in the same to the Grantors.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its lien on and security interest in, to and under all of each Grantor’s respective right, title and interest in and to the following (collectively the “Trademark Collateral”):

- (a) all of its Trademarks referred to on Schedule 1 hereto;
- (b) all renewals and extensions of the foregoing;
- (c) all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark; and
- (d) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Agent hereby reassigns, grants and conveys to each respective Grantor, without any representation, recourse or undertaking by Agent, any and all of Agent’s right, title and interest in, to and under the Trademark Collateral. Agent hereby authorizes Grantors (or their designee) to file this Release with the United States Patent and Trademark Office.

3. Agent represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademark Collateral; (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an application to register any trademark, or any trade name or assumed name of or by any Grantor, other than those marks set forth on Schedule 1 (attached hereto), in

any jurisdiction throughout the world, other than such filings made in the United States Patent and Trademark Office.
