

Seller agrees to execute, acknowledge and deliver any further deeds, assignments, conveyances and other assurances, documents and instruments of transfer and take such other reasonable actions consistent with the foregoing as may be necessary to carry out the intent of this Assignment.
3. Binding. This Assignment shall be binding upon and obligate Buyer and Seller and shall be binding upon and obligate their respective successors and assigns.


