Assignor hereby covenants and warrants that as of the date hereof it is the true and lawful owner of the entire right, title, and interest in the Marks and the goodwill of the business symbolized thereby, that it has the full right and power to convey the same, that the same are free and clear of all liens, charges, and encumbrances whatsoever, and that it has not executed and will not execute any agreement in conflict herewith.

Assignor agrees to execute any further documents that may be needed in the future to record and vest full title in and to the Marks in Assignee.

This Assignment shall be governed by and construed and interpreted in accordance with the laws of the State of Delaware without regard to conflict of laws principles.


