TRADEMARK ASSIGNMENT

Assignor hereby conveys, transfers, assigns, and delivers to Topia all of Assignor's rights, title, and interest in, to, and under the Marks, including all common law rights connected therein; together with the goodwill of the business symbolized thereby and associated therewith, and any registrations of and applications to register the Marks, including the Registrations; and together with all claims for damages by reason of past, present, or future infringement or other unauthorized use of the Marks, and with the right to sue for and collect damages.

Assignor further covenants that it will execute all documents, papers, forms, and authorizations and take all other actions that may be necessary for securing, completing, or vesting in Topia full rights, title, and interest in and to the Marks.
