**FOURTH:** The merger is to become effective as of 12:01am on October 1, 2014.

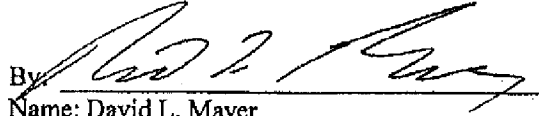
