

MEMORANDUM OF SECURITY AGREEMENT
(Trademarks)

Pursuant to a Trademark Security Agreement dated as of the Closing Date (as defined in the Security Agreement, as defined herein) (as amended and in effect immediately prior to the date hereof, collectively, the "Security Agreement"), Connor Concepts, Inc., a Tennessee corporation, has granted to CapitalSpring Agency Services, LLC, as Agent for the Lenders (as defined in the Security Agreement) (the "Secured Party"), a continuing security interest in, and a continuing lien upon, the Collateral (as that term is defined in the Security Agreement), including the trademarks listed on the annexed Schedule 1, and all applications, registrations, renewals and proceeds (including accounts receivable and royalties) thereof (the "Trademarks"), together with the goodwill of the business connected with the use of and symbolized by the Trademarks. The Secured Party's security interest in the Trademarks can be terminated only in accordance with the terms of the Security Agreement.




