**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of November 22, 2019 and granted by Wells Fargo Bank, National Association (“Lender”) pursuant to the Amended and Restated Loan and Security Agreement, dated December 17, 2015, among Kent International Inc., a Delaware corporation (“Debtor”), certain affiliates of Debtor and Lender (as amended, the “Loan Agreement”), and the Amended and Restated Trademark Collateral Assignment and Security Agreement, dated as of December 17, 2015, between Debtor and Lender recorded with U.S. Patent and Trademark Office on January 5, 2016, at Reel 5702, Frame 0836 (the “Trademark Security Agreement” and together with the Loan Agreement, the “Security Agreements”), in favor of Debtor. Capitalized terms used but not otherwise defined herein have the meanings set forth in the Trademark Security Agreement.


WHEREAS, pursuant to the terms and conditions of the Security Agreements, Debtor granted to Lender a continuing security interest in, and a general lien upon, all of its right, title and interest in, to and under the Trademarks, including those set forth on Schedule I hereto, all goodwill associated with such Trademarks and all proceeds of any and all of the foregoing (as further defined in the Trademark Security Agreement, collectively, the “Collateral”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby terminates, cancels, re-pledges, reassigns and releases to Debtor any and all rights, title, interest, liens and security interests in the Collateral, and all goodwill associated with such Trademarks, without representation, warranty or recourse of any kind.

This Release shall be construed in accordance with and governed by the law of the State of New York.
