**RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made effective as of November 25, 2019, by TEXAS CAPITAL BANK, NATIONAL ASSOCIATION, a national banking association (the “Secured Party”), in favor of MEDIA RECOVERY, INC., a Nevada corporation (“Debtor”).

WHEREAS, the Debtor has granted security interests to the Secured Party under the Trademark Security Agreement dated as of March 21, 2018 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, the Debtor granted the Secured Party, among other collateral as set forth therein, a security interest in and lien on the trademarks identified on Exhibit A hereto (the “IP Collateral”);

WHEREAS, the granting of the security interest in the IP Collateral was recorded with the United States Patent and Trademark Office against the IP Collateral on April 3, 2018 at Reel number 6306 and Frame number 0852; and

WHEREAS, the Debtor has requested that the Secured Party terminate and release its security interests in and liens on the IP Collateral.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1) Definitions. All capitalized terms not defined in this Release shall have the respective meaning given to them in the Security Agreement.

2) Termination and Release of Security Interest. The Secured Party hereby terminates, releases, and discharges its security interest in and liens on the IP Collateral, including, without limitation, the trademarks listed on Exhibit A hereto, and the Secured Party hereby assigns and transfers to the Debtor, without representation, warranty or recourse, all of the Secured Party’s right, title and interest in and to such trademarks, effective as of the date set forth above.


