RELEASE OF TRADEMARK SECURITY INTEREST

November 25, 2019

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank of America, N.A., as administrative agent (the "Administrative Agent"), pursuant to that certain Security and Pledge Agreement dated December 7, 2016, by and among the grantors from time to time party thereto (each a "Grantor" and collectively, the "Grantors") and the Administrative Agent for the Secured Parties referenced therein (as the same may have been amended, modified, restated, or supplemented from time to time, the "Security Agreement"), does hereby unconditionally and expressly release, terminate and forever discharge and extinguish any and all of its right, title and interest in and to any and all liens and security interests it may have under all intellectual property collateral identified in the Security Agreement and that certain Notice of Grant of Security Interests in Trademarks dated December 7, 2016 (the "Trademark Security Agreement" and together with the Security Agreement, the "Security Agreements"), including, without limitation, the trademarks listed on Schedule 1 attached hereto (collectively, the "Released Collateral"), arising from the Security Agreements, which was recorded in the United States Patent and Trademark Office ("PTO") on or about July 24, 2018, against the United States trademarks listed on Schedule 1 at Reel/Frame Numbers 6389/0164. The Administrative Agent hereby (i) terminates, releases, discharges, retransfers and reassigns to Grantor the security interest and all of the Administrative Agent's right, title and interest in, to and under the Released Collateral and (ii) terminates the Trademark Security Agreement (the "Release and Termination"). The Administrative Agent will take all such further actions, execute and deliver, at the request and cost of Grantor, such further instruments, documents and release forms as Grantor may reasonably request or are required to more effectively release, terminate, discharge, and extinguish any such liens and security interests upon such Released Collateral.

This Release and Termination shall be binding upon the Administrative Agent, its legal representatives, assigns and successors. The Administrative Agent hereby authorizes Grantor or any of its authorized representatives to file this Release and Termination with the PTO or any other applicable governmental office and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release and Termination.
