## RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

WHEREAS, Mor Furniture for Less, Inc., a California corporation ("Grantor"), with its chief executive office at 6965 Consolidated Way, Suite B, San Diego, California 92121, granted a security interest in and lien upon intellectual property and certain trademarks and related rights to Bank of America, N.A., a national banking association ("Collateral Agent") as set forth in the Intellectual Property Security Agreement, dated June 26, 2009, by Grantor in favor of Collateral Agent (the "Security Agreement");

WHEREAS, an executed copy of the Security Agreement was recorded in the United States Patent and Trademark Office on July 18, 2009 at Reel 004027 Frame 0121;

WHEREAS, the indebtedness owing to the Collateral Agent and secured by the Security Agreement has been repaid in full, and the Grantor has requested that Collateral Agent release and reassign its interest in the intellectual property and trademarks more fully identified in Schedule A annexed hereto and made a part hereof; together with the goodwill of the business symbolized thereby;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Collateral Agent hereby:

1. releases and reassigns to Grantor any and all liens, security interests, right, title and interest of Collateral Agent pursuant to the Security Agreement in the intellectual property and trademarks more fully identified in Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby, without recourse or representation or warranty, express or implied, of any kind;
2. agrees that any power of attorney or similar rights granted by Grantor to Collateral Agent pursuant to or in connection with the Security Agreement is terminated; and
3. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.
