DECLARATION OF PETER GAINSLEY

I, Peter Gainsley, Chief Executive Officer of Animal Adventure, LLC, a Delaware limited liability company, hereby provide the following information relating to the U.S. trademark registration **BABY ADVENTURE**, Registration Number 4,674,686 (the "Registration"):

The present Registration contains an error relating to the ownership. The manner in which this mistake arose is as follows:

- On September 26, 2008, the U.S. trademark registration **BABY ADVENTURE**, reg. no. 2,522,267, was cancelled (the "Cancelled Mark").
- On August 5, 2014, a Trademark Assignment between Animal Adventure, Inc., a Minnesota corporation, and Animal Adventure, LLC, a Delaware limited liability company, identifying numerous U.S. trademark applications and/or registrations was recorded with the U.S. Trademark Office (the "Assignment"). However, the Assignment inadvertently reflected the trademark registration **BABY ADVENTURE**, reg. no. 2,522,267 (the Cancelled Mark) vs. the trademark registration **BABY ADVENTURE**, reg. no. 4,674,686 (the Registration).
- Attached is a copy of the originally recorded document (the Assignment) with the corrections thereto initialed and dated by the party signing the Declaration.
- The incorrect information concerning the good faith error in the Assignment relating to the Registration was just now detected. Thus, the Assignment document should have correctly identified the Registration vs. the Cancelled Mark.
- Therefore, the Assignee requests a correction to reflect the owner of the Registration as: Animal Adventure, LLC, a Delaware limited liability company.
- The Assignor of the Assignment is not available and, therefore, an officer of the Assignee who has firsthand knowledge of the facts is submitting the Declaration for recordation.
- In light of the circumstances, the Assignee believes that: the typographical error in the recorded assignment document occurred in good faith, he identified the current owner of the



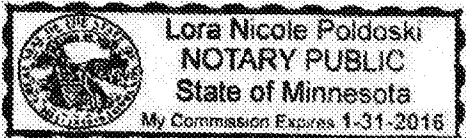
