## ASSIGNMENT

**THIS ASSIGNMENT** is made this 11 day of November 2019  
**BETWEEN Rynel, Inc.** with an address at 11 Twin Rivers Drive, Wiscasset, Maine 04578, United States of America (a US incorporated company registered in Delaware) (hereinafter called "the assignor") of the one part and **Mölnlycke Health Care AB** with an address at Gamlestadvägen 3C, 415 02, Gothenburg, Sweden (a Swedish limited company) (hereinafter called "the assignee") of the other part.

### WHEREAS:-

- (A) The assignor is the registered proprietor of the trade mark registrations, details of which are set out in the schedule hereto (hereinafter referred to as "the trade marks").
- (B) The assignor has agreed to assign the trade mark to the assignee for the consideration hereinafter appearing.

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:-

#### 1. Assignment

In consideration of the sum of one pound (£1) now paid by the assignee to the assignor (the receipt whereof is hereby acknowledged by the assignor), the assignor hereby assigns with full title guarantee the trade marks and all right, title and interest therein together with the goodwill symbolised in the trade marks and together with all rights of action, remedies, powers and benefits relating to the trade marks, including the right to sue for damages for infringement occurring before the date of this assignment.

## **2. Further Assurance**

The assignor undertakes that, at the request and expense of the assignee, it will execute all such documents, forms and authorisations and depose to or swear any declaration or oath as may be necessary under the law of any country for completing the transfer to the assignee of the full right, title and interest to any of the rights assigned by clause 1.

## **3. Applicable Law and Jurisdiction**

This assignment and any dispute or claim arising out of or in connection with it shall be governed by and construed in accordance with the laws of England and all disputes or claims arising out of or relating to this assignment shall be subject to the exclusive jurisdiction of the English courts to which the parties irrevocably submit.




