TERMINATION OF  
SECURITY INTEREST IN TRADEMARKS AND PATENTS

WHEREAS, Menon Renewable Products, Inc., a Delaware corporation with its principal place of business at 500 La Terraza Boulevard, Suite 150, Escondido, CA 92025 (the "*Grantor*"), is the owner of record of the trademarks and applications (collectively, the "*Trademarks*") listed on the attached Exhibit A, now issued or pending in the United States Patent and Trademark Office (the "*PTO*"); and

WHEREAS, the Grantor is the owner of record of the patents and patent applications (collectively, the "*Patents*") listed on the attached Exhibit B, now issued or pending in the PTO; and

WHEREAS, the Grantor entered into that certain Security Agreement, dated as of May 20, 2016 (the "*Security Agreement*"), between the Grantor and Bumble Bee Foods, LLC, a Delaware limited liability company ("*Bumble Bee*"); and

WHEREAS, Bumble Bee recorded that certain UCC financing statement with the United States Patent and Trademark Office three separate times: (i) on June 13, 2016 at Reel 038980, Frame 0511; (ii) on June 15, 2015 at Reel 038980, Frame 0575, and (iii) on July 18, 2016 at Reel 039383, Frame 0384 (collectively, the "*Bumble Bee Recordings*"); and

WHEREAS, Bumble Bee assigned and transferred to Big Catch/MRP Cayman, Ltd, a limited liability company incorporated in the Cayman Islands (the "*Secured Party*"), all of its right, title, and interest in, to, and under the Security Agreement, pursuant to the terms and conditions of that certain Assignment and Assumption Agreement dated August 18, 2017, which assignment and transfer included, among other things, all of Bumble Bee's right, title, and interest in, to, and under the Bumble Bee Recordings and that certain recording with the United States Patent and Trademark Office on September 15, 2017 at Reel 006155, Frame 0851; and

WHEREAS, the Secured Party desires to release its security interest in the Trademarks and Patents and to terminate the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Secured Party hereby:

1. Releases and reassigns to the Grantor any and all liens, security interests, right, title and interest of Secured Party pursuant to the Security Agreement in the Trademarks more fully described on Exhibit A, without recourse or representation or warranty, express or implied; and
2. Releases and reassigns to the Grantor any and all liens, security interests, right, title and interest of Secured Party pursuant to the Security Agreement in the Patents more fully described on Exhibit B, without recourse or representation or warranty, express or implied; and

3. Authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the releases hereby given.
