**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Agreement”) dated as of **December 3, 2019**, from Gordon Brothers Brands, LLC, in its capacity as Lender party to the Credit Agreement (the “Lender”), in favor of Ursa Minor B.V., a company incorporated under the laws of the Netherlands (the “Grantor”).

WITNESSETH:

WHEREAS, in connection with the Trademark Security Agreement, dated as of August 24, 2017 (the “Trademark Security Agreement”), the Lender was granted a security interest in all of Grantor’s right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement) (all capitalized terms used herein, but not otherwise defined herein, shall have the meanings set forth or referenced in the Trademark Security Agreement, as applicable);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Assignment Division of the United States Patent and Trademark Office (the “USPTO”) on August 24, 2017 at Reel 006137, Frame 0478; and


WHEREAS, the Lender now wishes to release its liens on, and security interests in, the Trademark Collateral in the Trademark Security Agreement, including, without limitation, the trademarks as set forth on Schedule A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Agreement, the Lender hereby states as follows:

1. Release of Security Interest. The Lender hereby terminates, releases and discharges all of its security interest in the Trademark Collateral, and reassigns any and all right, title and interest that it may have in or to the Trademark Collateral to the Grantor.
2. Recordation. The Grantor or its authorized agent is authorized to record this Agreement with the USPTO.
3. Governing Law. This Agreement and the rights and obligations of the parties under this agreement shall be construed in accordance with and governed by the laws of the State of New York.
4. Further Assurances. The Lender shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by the Grantor, and at Grantor’s cost and expense, to more fully and effectively effectuate the release of liens contemplated hereby.


