WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on September 18, 2017, at Reel 6156, Frame 0467; and


WHEREAS, Secured Party has agreed to terminate and release its security interest and all of its right, title and interest in and to each of the Trademarks.
