ARTICLES OF ORGANIZATION
OF
PEPTIDES INTERNATIONAL, LLC

The undersigned, serving as the organizer, pursuant to KRS Chapter 275, hereby executes the following Articles of Organization on November 30, 2019, for the purpose of forming a Kentucky limited liability company under the Kentucky Limited Liability Company Act.

ARTICLE I

NAME

The name of the limited liability company shall be Peptides International, LLC (the "Company").

ARTICLE II

CONVERSION; FORMER NAME

The Company is the result of the conversion of Peptides International, Inc., a Kentucky corporation (the "Corporation"), into a limited liability company pursuant to KRS 275.376. The former name of the Company was Peptides International, Inc.

ARTICLE III

APPROVAL OF CONVERSION

The conversion of the Corporation into the Company pursuant to KRS 271B.12-030 and KRS 275.376 required shareholder approval, which approval was obtained from the sole shareholder of the Corporation by written consent in lieu of a meeting on November 27, 2019. The designation, number of outstanding shares, number of votes entitled to be cast by each voting group entitled to vote separately on the plan of conversion of the Corporation, and number of votes of each voting group indisputably represented by unanimous written consent, were as follows:

Number of Votes Indisputably Represented by Unanimous Written Consent:	1123.6

The total number of undisputed votes cast in favor of the conversion was 1123.6 out of 1123.6, which was sufficient approval of the conversion in accordance with the Corporation's Articles of Incorporation and Bylaws and the Kentucky Business Corporation Act.

ARTICLE IV

REGISTERED OFFICE AND REGISTERED AGENT

The registered office of the Company shall be located at 11621 Electron Drive, Louisville, Kentucky 40299. The initial registered agent at that address is Jacquelyn Spatola.

PRINCIPAL OFFICE

ARTICLE V

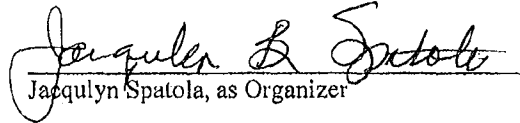
STATEMENT OF MANAGEMENT

The affairs of the Company are to be managed by its Member, subject to the terms of the Company's Operating Agreement.

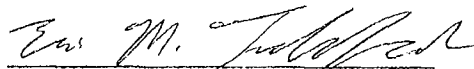
