RELEASE OF TRADEMARK COLLATERAL ASSIGNMENT AND SECURITY AGREEMENT

This RELEASE OF TRADEMARK COLLATERAL ASSIGNMENT AND SECURITY AGREEMENT (this "Release"), effective as of May 23, 2017 is made by WELLS FARGO BANK, NATIONAL ASSOCIATION ("Factor") in favor of MARCRAFT CLOTHES, INC. ("Client"). Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Trademark Security Agreement (as defined below).

WITNESSETH:

WHEREAS, pursuant to the Factoring Agreement, Client and Factor entered into that certain Trademark Collateral Assignment and Security Agreement, dated as of July 14, 2014 (the "Trademark Security Agreement"), an executed copy of which was recorded in the United States Patent and Trademark Office on January 15, 2015, at Reel 5446, Frame 0365;

WHEREAS, pursuant to the Trademark Security Agreement, Client unconditionally granted, assigned, and pledged to Factor a continuing security interest (the "Security Interest") in all of Client's right, title and interest in and to the following, whether then owned or thereafter acquired or arising Collateral.

WHEREAS, Client has requested that Factor release and reassign to Client its Security Interest in the Collateral; and

WHEREAS, Factor has duly authorized the execution, delivery and performance of this Release.


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Factor agrees as follows:

1. Release of Security Interest. Factor does hereby terminate, release and discharge its Security Interest in the Collateral, and hereby reassigns to Client any right, title or interest it may have in the Collateral, without recourse or representation or warranty, express or implied, of any kind.
2. Termination of Special Power of Attorney. Factor does hereby agree that any power of attorney or similar rights granted by Client to Factor pursuant to or in connection with the Trademark Security Agreement is terminated.
3. Purpose. Factor does hereby authorize and request that the United States Patent and Trademark Office note and record the existence of the release hereby given.
