Trademark Assignment

This trademark assignment (the "Agreement") is made and entered into as of the last date written below (the "Effective Date"), by and between **NG Intermedia Aps**, a Denmark company with a business address of 3th Hollaendervej 26, Copenhagen, Denmark 1855 ("NG") and **SeniorConnections LLC**, a Delaware limited liability company with a business address of 7114 East Stetson Drive, Suite 400, Scottsdale, Arizona 85251 ("SeniorConnections").

WHEREAS, NG is the owner and beneficiary of all right, title, and interest in and to the trademark SENIORCONNECT (the "Mark"), including U.S. Trademark Registration No. 3,895,603 (the "U.S. Registration"), International Trademark Registration No. 1,053,875 (the "International Registration"), and rights granted through designation of protection from the International Registration into the United Kingdom ("U.K. Designation"); and

WHEREAS, NG desires to convey, assign, and transfer to SeniorConnections all right, title, and interest in and to the Mark and the goodwill of the business associated with the Mark, and SeniorConnections desires to acquire the Mark (including registrations therefor), and the goodwill of the business associated with the Mark.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. NG hereby irrevocably conveys, assigns, and transfers to SeniorConnections all right, title, and interest in, to, and under the Mark worldwide, including all common law rights in, to, and under the Mark, all goodwill of the business associated with the Mark, all applications and registrations for the Mark, including the U.S. Registration, the International Registration, and the U.K. Designation, and all claims for damages by reason of past, present, or future infringement or other unauthorized use of the Mark, with the right to sue for and collect damages.
2. NG will execute all documents and take all other actions that might be necessary for confirming, securing, completing, or vesting in SeniorConnections all right, title, and interest in and to the Mark and registrations therefor.
