C. All rights to damages or profits, due or to become due, accrued or to accrue, arising out of past, present, or future infringement of said Trademarks and Related Rights or injury to said Goodwill, together with the right to sue or recover the same in the Assignor's name.

This instrument is made and delivered by Assignor pursuant and subject to the terms of a certain Asset Purchase and Sale Agreement entered into by and among AIS Industries, Inc., Assignor, Threshold Technologies, Inc. and Assignee, of even date herewith (the "Purchase Agreement"). Defined terms employed herein shall have the meaning ascribed to them in the Purchase Agreement unless otherwise specifically set forth herein.

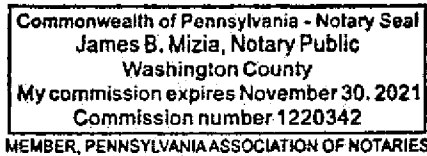
