AMENDED AND RESTATED INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS AMENDED AND RESTATED INTELLECTUAL PROPERTY SECURITY AGREEMENT is entered into as of December 3, 2018 by and between PINC Solutions, a California corporation ("Grantor") and Avidbank, a California corporation ("Bank").

RECITALS

Bank has agreed to make certain advances of money and to extend certain financial accommodations to Grantor in the amounts and manner set forth in that certain Loan and Security Agreement by and between Bank and Grantor dated of August 22, 2016 and as amended from time to time (the "Loan Agreement"). In connection therewith, Grantor and Bank entered into that certain Security Agreement -- Intellectual Property dated as of August 22, 2016 (the "Original Agreement"). Capitalized terms used herein have the meaning assigned in the Loan Agreement. In connection with an amendment to the Loan Agreement being entered into by Bank and Grantor on or around the date hereof, the parties desire to amend and restate the Original Agreement in accordance with the terms set forth herein.

NOW, THEREFORE, Bank and Grantor agree as follows:

AGREEMENT

To secure performance of Grantor's obligations under the Loan Agreement, Grantor grants to Bank a security interest in all of Grantor's right, title and interest in Grantor's intellectual property (including without limitation those Copyrights, Patents, Trademarks and Mask Works listed on Exhibits A, B, C and D hereto), including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits). This security interest is granted in conjunction with the security interest granted to Bank under the Loan Agreement. Each right, power and remedy of Bank provided for pursuant to this Agreement or in the Loan Agreement shall not preclude the simultaneous or later exercise by Bank of any or all other rights, powers or remedies.

This Agreement hereby amends and restates the Original Agreement in its entirety, without novation.

This Agreement may be executed in two or more counterparts, each of which shall be deemed an original but all of which together shall constitute the same instrument. In the event that any signature to this Agreement is delivered by facsimile transmission or by e-mail delivery of a ".pdf" format data file, such signature shall create a valid and binding obligation of the party executing (or on whose behalf such signature is executed) with the same force and effect as if such facsimile or ".pdf" signature page were an original thereof.


