

INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT (this "IP Assignment"), is made and entered into between Hayes Manufacturing, Inc., a corporation of Michigan with offices at 6875 US-131, Fife Lake, Michigan 49633 ("Assignor"), and Western Diesel Services, Inc., a corporation of Delaware with offices at 1100 Research Blvd., St. Louis, Missouri 63132 ("Assignee").

NOW THEREFORE, in consideration of the premises, the covenants and the agreements contained herein and in the Agreement, and other good and valuable consideration, the receipt and sufficiency of which hereby are acknowledged, the parties hereto agree as follows:

- 1. Assignor does hereby assign and transfer to Assignee all right, title and interest in and to the Registered IP and the other Intellectual Property Assets, together with the Assignor's common law rights thereto and the goodwill associated therewith, all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world, together with all income, royalties or payments in respect of the Registered IP and the other Intellectual Property Assets due or payable as of the date hereof or thereafter, including all claims for damages by reason of past, present or future infringement or other unauthorized use of the Registered IP and the other Intellectual Property Assets, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.
- 2. Assignor hereby appoints Assignee to file and record this instrument with the United States Patent and Trademark Office and all other applicable national offices. Assignee shall request the Commissioner of Patents and Trademarks of the United States and the director of all other national offices to record Assignee as owner of the Registered IP, including any variations thereof, for the sole use and enjoyment of the Assignee and for the use and enjoyment of its successors, assigns or other legal representatives.
- 3. Assignor shall provide Assignee, its successors, assigns or other legal representatives, with reasonable cooperation and assistance at Assignee's request and expense (including the execution and delivery of any and all documentation as may be reasonably required) in the recordation of this Assignment.
- 4. This Assignment will in all respects be interpreted, read, construed and governed by the internal laws of the State of Missouri, exclusive of its conflicts of law rules.
