**RELEASE OF SECURITY INTEREST  
IN CERTAIN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN CERTAIN TRADEMARK COLLATERAL, dated as of December 5, 2019 (this "Release"), is made by **CITIBANK, N.A.**, in its capacity as collateral agent pursuant to the Credit Agreement (as defined in the Security Agreement) (in such capacity, the "Collateral Agent"), in favor of **IHEARTMEDIA + ENTERTAINMENT, INC.** (the "Grantor"), as follows.

WHEREAS, the Grantor is party to a Security Agreement dated as of May 1, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof, the "Security Agreement") in favor of the Collateral Agent pursuant to which the Grantor executed and delivered the trademark security agreement described below;

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of May 1, 2019, and recorded with the U.S. Patent and Trademark Office on May 2, 2019, at Reel/Frame No. 6635/0671 (as amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof, the "Trademark Security Agreement"), the Grantor granted to the Collateral Agent a security interest in all right, title or interest in, to and under, the Collateral (as defined in the Trademark Security Agreement) described therein, including, without limitation, the United States trademark registration set forth on Schedule A attached hereto (such registration, the "Released Trademark");

WHEREAS, the Grantor has requested that the Collateral Agent release its security interest in the Released Trademark;

WHEREAS, the Collateral Agent now desires to terminate and release its security interest in the Released Trademark as provided in this Release;


