RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (this "Release"), dated as of December 4, 2019, is made by **THE HUNTINGTON NATIONAL BANK**, a national banking association, ("Secured Party"), and is as follows:

WHEREAS, XPRESS GLOBAL SYSTEMS, LLC, a Georgia limited liability company ("Debtor"), and Secured Party are parties to that certain Grant of Security Interest in United States Trademarks dated May 15, 2019, which was recorded with The United States Patent and Trademark Office on May 15, 2019 at Reel 6646, Frame 0191 (the "Agreement"); capitalized terms used, but not defined, herein will have the meaning given to them in the Agreement;

WHEREAS, the Agreement granted to the Secured Party a security interest in all of the Debtor's right, title and interest in, to and under the Marks, including, without limitation: (a) all of Debtor's right, title and interest in and to all of its then or in the future owned or existing Marks, including such Marks listed on Schedule A of the Agreement (attached hereto and made a part hereof as Schedule A); (b) all renewals of each of the Marks; (c) all income, royalties, damages and payments now and in the future due or payable under, or with respect to, any and all Marks, including damages and payments for past or future infringements of any and all Marks; (d) all rights to sue for past, present and future infringements of any and all Marks; (e) all rights corresponding to each of the Marks throughout the world; (f) all rights of Debtor as licensor or licensee under, and with respect to, trademarks, service marks, trade names, and trademark and service mark applications, including the licenses listed on Schedule A of the Agreement attached hereto and made a part hereof as Schedule A); and (g) together in each case with the goodwill of Debtor's business connected with the use of, and symbolized by, the foregoing; and


WHEREAS, Secured Party desires to release its rights and security interests in the Marks.
