Pursuant to Section 904 of the New York Business Corporation Law (the "NYBCL"), the undersigned hereby certify as follows:

**FIRST:** The name and state of incorporation of each of the constituent corporations are as follows:

- a) Pedinol Pharmacal, Inc., a New York corporation ("Pedinol").
- b) Bausch & Lomb Incorporated, a New York corporation ("Bausch"). The name under which Bausch & Lomb Incorporated was originally formed is Bausch & Lomb Optical Company.

**SECOND:** The name of the surviving corporation (the "Surviving Corporation") is Bausch & Lomb Incorporated.

**THIRD:** The designation, number and voting rights of each outstanding class and series of shares for each of the constituent corporations are as follows:

- a) The certificate of incorporation of Pedinol was filed with the Department of State on December 4, 1970.

- b) The certificate of incorporation of Bausch & Lomb Incorporated was filed with the Department of State on March 20, 1908.

FIFTH: The merger was authorized with respect to Pedinol in the following manner: A plan of merger was adopted by the board of directors of Pedinol by unanimous written consent on December 14, 2018. The board submitted the plan of merger to a shareholder vote. The plan of merger was adopted by written consent of the sole shareholder of Pedinol on December 14, 2018.

SIXTH: The merger was authorized with respect to Bausch in the following manner: A plan of merger was adopted by the board of directors of Bausch by unanimous written consent on December 14, 2018. The board submitted the plan of merger to a shareholder vote. The plan of merger was adopted by written consent of the sole shareholder of Bausch on December 14, 2018.

SEVENTH: The certificate of incorporation of Bausch, as in effect immediately prior to the effective date of the merger, shall be the certificate of incorporation of the Surviving Corporation.
