WHEREAS, Assignor is the owner of the registrations listed in Schedule A and any common law rights in the underlying marks (the "Trademarks"); and


WHEREAS, Assignee wishes to acquire all of Assignor's rights in and to the Trademarks and the good will associated therewith;
