TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of December 5, 2019, by WINTRUST BANK, N.A. formerly known as NORTH SHORE COMMUNITY BANK & TRUST COMPANY, an Illinois state chartered bank ("Secured Party"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, FOCUS POINTE HOLDINGS, INC., a Delaware corporation, MARKETLAB RESEARCH, INC., a Pennsylvania corporation, and DELVE LLC, a Missouri limited liability company (each a "Grantor" and, collectively, "Grantors") and Secured Party were parties to that certain Trademark Security Agreement dated as of March 28, 2014 (the "Security Agreement") pursuant to which Grantors granted a security interest to Secured Party in certain Trademarks and Trademark Collateral (as defined below) as security for certain obligations owing by Grantors to Secured Party, including the Trademarks set forth on Schedule A hereto;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on March 28, 2014, at Reel 5248, Frame 0438;

WHEREAS, Grantors have requested that Secured Party release its security interest in the Trademarks and Trademark Collateral and reassign any and all rights in the same to Grantors; and

WHEREAS, Grantors have satisfied and fulfilled all of their obligations to release the Secured Party's security interest in the Trademarks and Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby releases its security interest in all of Grantors' right, title and interest in and to the following (collectively the "Trademark Collateral"):

(i) each Trademark listed on Schedule A annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark; and


(ii) all products and proceeds of the foregoing, including without limitation, any claim by Grantors against third parties for past, present or future (i) infringement or dilution of each such Trademark or (ii) injury to the goodwill associated with each such Trademark.

2. Secured Party hereby reassigns, grants and conveys to Grantors, without any representation, recourse or undertaking by Secured Party, any and all of Secured Party's right, title and interest in and to the Trademarks and the Trademark Collateral.
