## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated as of December 5, 2019 (this "Release") is made by Comerica Bank (the "Secured Party"), under the Security Agreement dated as of May 5, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") by and between the Secured Party and Equibrand Entertainment Group L.P. (the "Debtor"), and recorded May 11, 2011 in the records of the United States Patent and Trademark Office at Trademark Reel 004540, Frame 150 through Frame 167.

Pursuant to the Security Agreement, the Debtor granted to the Secured Party a security interest ("Security Interest") in the Debtor's trademark collateral, including but not limited to the trademarks listed on attached Exhibit A (the "Released Trademarks").

The Secured Party now wishes to release and terminate its Security Interest in the Released Trademarks only.
