NOW, THEREFORE, in consideration of good and valuable consideration paid by Assignee to Assignor, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby sell, assign and transfer to Assignee, its successors and assigns, all of Assignee's right, title and interest in said trademark application together with all of the goodwill of the business in connection with which the Mark is used, and with the full right to sue in law or equity, in order to protect the Mark and the right to recover for any past or future infringement of the Mark and any and all other rights and remedies associated with the use, ownership and registration of the Mark throughout the world.
