

CERTIFICATION OF OWNERSHIP

WHEREAS, Utvecklings Aktiebolaget Uranienborg is a company formed and existing under the laws of Sweden (the "Company");

WHEREAS, all of the Company's capital stock is owned by Hexagon AB, a company formed and existing under the laws of Sweden (the "Parent Company");

WHEREAS, Brown & Sharpe, Inc., formerly known as Hexagon (Rhode Island), Inc., is an indirect wholly-owned subsidiary corporation of the Parent Company formed and existing under the laws of the State of Delaware ("Brown & Sharpe");

WHEREAS, the Parent Company, as buyer, and BNS, Co. (formerly known as Brown & Sharpe Manufacturing Company), as seller ("Seller"), entered into an Acquisition Agreement dated as of November 16, 2000 (the "Acquisition Agreement") for the sale by Seller to the Parent Company, or one or more of the affiliates of the Parent Company to be designated by it, of substantially all of the assets of Seller, at a closing (the "Closing") to be held promptly following the satisfaction of the conditions precedent thereto set forth in the Acquisition Agreement;

WHEREAS, pursuant to the Designation of Buyer Affiliates, dated as of April 27, 2001 (the "Designation"), executed and delivered by the Parent Company to the Seller, the Parent Company assigned to the Company the right of the Parent Company to receive, pursuant the Acquisition Agreement, an assignment of the Metrology Intellectual Property (as such term is defined in the Acquisition Agreement) owned by the Seller;

WHEREAS, pursuant to the Designation, the Parent Company also assigned to Brown & Sharpe the right of the Parent Company to receive, pursuant to the Acquisition

Agreement, the Metrology Stock and the Metrology Assets (as such terms are defined in the Acquisition Agreement);

WHEREAS, in order to effectuate the assignment of the Metrology Intellectual Property by the Parent Company to the Company, it was necessary to execute and deliver in connection with the Closing the following agreements and instruments (collectively referred to herein as the "IP Assignment Documents"):

1. Assignment of Intellectual Property, between Seller and the Company, dated as of April 27, 2001;
2. Assignment by Seller to the Company of all its rights, title and interest in registered trademarks of Seller, dated as of April 27, 2001;
3. Assignment by Seller to the Company of all of its right, title and interest in patents and patent applications, dated as of April 27, 2001;
4. Nunc Pro Tunc Transfer and Assignment of a Joint Interest in Assets, between Brown & Sharpe and the Company, dated as of April 27, 2001; and
5. Release and Quitclaim of a Joint Interest in Certain Assets, between the Company and Brown & Sharpe, dated as of May 4, 2001.

WHEREAS, prior to the Closing under the Acquisition Agreement, the respective management of the Company and the Parent Company determined that the name of the Company should be changed from "Utvecklings Aktiebolaget Uranienborg" (the "Present Name") to "Brown & Sharpe Holding AB" (the "Proposed Name");

WHEREAS, on or about October 8, 2001, the Parent Company applied to the Swedish Patent and Registration Office (the "PRV") to change the name of the Company from the Present Name to the Proposed Name;

WHEREAS, on or about January 22, 2001, the Parent Company received notice from the PRV that its application to change the name of the Company to the Proposed Name had been denied;

WHEREAS, the Designation and the IP Assignment Documents refer to the Company under its Proposed Name, rather than its Present Name;

WHEREAS, to avoid possible confusion concerning the ownership interest of the Company in the Metrology Intellectual Property acquired from the Seller pursuant to the Acquisition Agreement and Designation, the undersigned parties hereto desire to execute this Certification of Ownership.

NOW THEREFORE, the undersigned parties do hereby certify as follows:

1. The name of the Company is, and at all times relevant to the transactions contemplated by the Acquisition Agreement, the Designation and the IP Assignment Documents was, "Utvecklings Aktiebolaget Uranienborg";

2. The reference in the Designation to "Brown & Sharpe Holding AB" was to the legal entity named "Utvecklings Aktiebolaget Uranienborg", a company formed and existing under the laws of Sweden;


3. The general assignment of the Metrology Intellectual Property to "Brown & Sharpe Holding AB" effectuated by the execution and delivery of the IP Assignment Documents effected a general assignment of such Metrology Intellectual Property to "Utvecklings Aktiebolaget Uranienborg" a company formed and existing under the laws of Sweden;

4. As a result of the execution and delivery of the IP Assignment Documents, all right, title and interest in the Metrology Intellectual Property has been fully assigned to "Utvecklings Aktiebolaget Uranienborg", a company formed and existing under the laws of Sweden.
