RELEASE OF SECURITY INTEREST IN TRADEMARKS
(SECOND LIEN)

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of November 25, 2019 (the “Effective Date”), is made by Macquarie US Trading LLC, in its capacity as Collateral Agent for the Secured Parties (in such capacity, the “Agent”), in favor of ALM Media Holdings, Inc., a Delaware corporation (“Holdings”), ALM Media, LLC, a Delaware limited liability company (“ALM”) and ALM Media Properties, LLC, a Delaware limited liability company (“ALMMP”) and together with Holdings and ALM, each a “Grantor” and collectively, the “Grantors”).

WHEREAS, pursuant to that certain Second Lien Security Agreement, dated as of July 31, 2014, by and among the Agent, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), the Grantors granted to the Agent, in its capacity as collateral agent, a security interest in and to certain collateral (including, without limitation, the Trademark Collateral (as defined below) set forth on Schedule I attached hereto);

WHEREAS, pursuant to the Security Agreement, (i) the Grantors executed and delivered that certain Trademark Security Agreement, dated as of July 31, 2014 (the “Trademark Security Agreement”) and (ii) ALM and ALMMP executed and delivered that certain Trademark Security Agreement, dated as of April 30, 2015 (the “Trademark Security Supplement” and, together with the Trademark Security Agreement, each a “Trademark Agreement” and collectively, the “Trademark Agreements”), in each case, for recordal with the United States Patent and Trademark Office; and

WHEREAS, (i) the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 3, 2014 at Reel/Frame 5335/0707 and (ii) the Trademark Security Supplement was recorded with the United States Patent and Trademark Office on May 19, 2015 at Reel/Frame 5519/0365;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Agreements, as applicable.

2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Collateral (as defined in the Trademark Agreements) (the “Trademark Collateral”), including, without limitation, the trademark registrations and applications set forth on Schedule I attached hereto, arising under the Security Agreement and the Trademark Agreements. If and to the extent that the Agent has acquired any right, title or interest in and to the Trademark Collateral under any Trademark Agreement, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the applicable Grantors.

3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels each Trademark Agreement.

4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantors and their respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by any Grantor, at such Grantor’s sole cost and expense, to more fully and

effectively effectuate the purposes of this Release. The Agent hereby authorizes and requests that the Commissioner for Trademarks of the United States Patent and Trademark Office record this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.




