RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), effective as of November 22, 2019 is made by WELLS FARGO BANK, NATIONAL ASSOCIATION ("Agent"), in favor of BAMFI, LLC, formerly known as BAM WORLDWIDE, LLC, a Georgia limited liability company ("Grantor"), pursuant to the Loan and Security Agreement, dated as of April 28, 2017 (as the same has been amended, amended and restated, supplemented or otherwise modified from time to time, the "Loan Agreement") among BAM Capital, LLC, a Georgia limited liability company, as borrower, Grantor, as guarantor, Agent, and the lenders party thereto.

W I T N E S S E T H:

WHEREAS, Grantor granted a continuing security interest in and lien upon certain trademarks and related rights to Agent, as set forth in that certain Trademark Security Agreement, dated as of April 28, 2017, made by Grantor in favor of Agent (as heretofore further amended, modified or supplemented, the "Trademark Security Agreement");

WHEREAS, an executed copy of the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on July 13, 2017, at Reel 6104, Frame 0508;

WHEREAS, Grantor has requested that Agent release and reassign its interest in the trademarks more fully identified in Exhibit A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby; and

WHEREAS, Agent has duly authorized the execution, delivery and performance of this Release.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Agent agrees as follows:

1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Loan Agreement and Trademark Security Agreement, as applicable (it being understood that, unless otherwise provided, in the event of any conflict, such terms shall have the meanings provided or provided by reference in the Loan Agreement).

2. Release of Security Interest. Agent does hereby release and reassign to Grantor its security interest in and lien upon all trademarks described in Exhibit A annexed hereto and made a part hereof, without recourse or representation or warranty, express or implied, of any kind.

3. Governing Law. This letter agreement shall be governed by, and construed and enforced in accordance with, the laws of the State of New York.
