**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of November 26, 2019, and made by WELLS FARGO, NATIONAL ASSOCIATION, having an office at 2450 Colorado Avenue, Suite 3000W, Santa Monica, California 90404 ("Wells Fargo"), to INSULECTRO, a California corporation (the "Company"), with an office at 20362 Windrow Drive, Lake Forest, California 92630.

WHEREAS, Company and Wells Fargo entered into that certain Trademark Security Agreement, dated August 12, 2016 (the "Security Agreement"), in which a security interest was granted by Company in favor of Wells Fargo in certain Trademarks (as defined in the Security Agreement);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on August 17, 2016, at Reel 5856, Frame 0983; and

WHEREAS, Wells Fargo now desires to terminate and release the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Wells Fargo hereby states as follows:


1. Definitions. The terms "Trademarks", as used herein, shall have the meaning set forth in the Security Agreement and shall mean and include all of the Company's right, title and interest of every kind and nature as of the date hereof, including in the trademarks listed on Schedule A attached hereto.

2. Release of Security Interest. Wells Fargo hereby terminates the Security Agreement, and terminates, releases and discharges its security interest in the Trademarks and reassigns to Company all right, title and interest it may have in and to the Trademarks without recourse and without any representation or warranty.
