THE CERTIFICATE OF INCORPORATION

Under Section 242 of the  
General Corporation Law of the State of Delaware

VT iDirect, Inc., a corporation organized and existing under the General Corporation Law of the State of Delaware (the "*General Corporation Law*")

**DOES HEREBY CERTIFY:**

FIRST: That the name of this corporation is VT iDirect, Inc. (the "*Corporation*").

SECOND: The Corporation was originally incorporated on January 19, 2000, under the name ComSoft Systems, Inc. A Certificate of Amendment was filed on November 2, 2000, changing its name to iDirect, Inc. A Certificate of Amendment was filed June 10, 2008, changing its name to VT iDirect, Inc.

THIRD: That the first sentence of Article FIRST of the Certificate of Incorporation, as amended, is hereby deleted in its entirety and replaced by the following:

"FIRST: The name of the corporation is ST Engineering iDirect, Inc."

FOURTH: Pursuant to Section 242(b)(1) of the General Corporation Law, no meeting or vote of the stockholders is required to adopt the proposed amendment.


FIFTH: That the foregoing amendment was duly adopted in accordance with Section 242 of the General Corporation Law.

SIXTH: That the foregoing amendment is to be effective on June 21, 2019 at 12:01 AM EDT.
