**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

This Release of Security Interest in Intellectual Property (this “Release”), effective as of December 6, 2019, is granted by Silicon Valley Bank, a California corporation (the “Bank”) to Earth Networks, Inc., a Delaware corporation (the “Grantor”), as follows:

WHEREAS, the Grantor has granted to the Bank a security interest in certain Intellectual Property Collateral (as defined in that certain Intellectual Property Security Agreement, dated as of March 27, 2015 and recorded with the United States Patent and Trademark Office at Reel/Frame 035327/646 and Reel/Frame 5487/0057 , as amended, restated, supplemented, or otherwise modified from time to time, hereinafter, the “Intellectual Property Security Agreement”), including without limitation the trademarks and the goodwill associated therewith, and the patents and patent applications, as set forth on Exhibit A attached hereto;

WHEREAS, the Bank wishes to release and restore all right, title and interest in and to the Intellectual Property Collateral to the Grantor and to terminate the Intellectual Property Security Agreement and dissolve any and all liens and encumbrances respecting the Intellectual Property Collateral under the Intellectual Property Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Bank hereby releases, discharges, and relinquishes unto the Grantor the security interests in the Intellectual Property Collateral.


