TRADEMARK ASSIGNMENT

2. Lipotriad hereby consents to the recordation of this Trademark Assignment in any applicable jurisdiction and before appropriate trademark offices. Lipotriad shall, upon the request and at the expense of PRN, execute any further documents reasonably required by PRN to secure and enforce the rights granted to PRN under this Trademark Assignment.

3. This Trademark Assignment is binding on Lipotriad, its successors and assigns, and will inure to the benefit of Lipotriad, its successors and assigns.
