Pursuant to Section 18-209 of the Limited Liability Company Act of the State of Delaware (the "DLLCA") and Section 264 of the General Corporation Law of the State of Delaware (the "DGCL")

Homestead Merger Sub 2, LLC does hereby certify:

FIRST: The names and states of organization or incorporation and domicile of the constituent entities to this merger are Homestead Merger Sub 2, LLC, a Delaware limited liability company (the "Company"), and Hotel Tonight, Inc, a Delaware corporation (the "Corporation").

SECOND: The Company and the Corporation have entered into an Agreement and Plan of Merger and Reorganization (the "Merger Agreement"), setting forth the terms and conditions of the merger of the Corporation with and into the Company pursuant to Section 18-209 of the DLLCA and Section 264 of the DGCL. The Merger Agreement has been approved, adopted, certified, executed and acknowledged in accordance with Sections 18-204 and 18-209 of the DLLCA in the case of the Company, and Sections 103 and 264 of the DGCL in the case of the Corporation.

THIRD: In accordance with the Merger Agreement, upon the effectiveness of the filing of this Certificate of Merger, the Corporation will merge with and into the Company (the "Merger"). The name of the company surviving the Merger is Homestead Merger Sub 2, LLC, and at the time of the Merger, it shall become Hotel Tonight, LLC (the "Surviving Company") and the separate corporate existence of the Corporation shall cease.

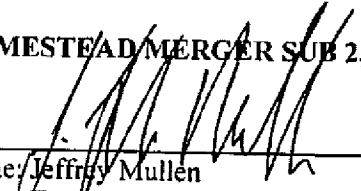
