RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks, dated as of December 16, 2019 (the “Trademark Security Release”), is made by ADAMS STREET CREDIT ADVISORS LP, a Delaware limited partnership, in its capacity as administrative agent (in such capacity, the “Administrative Agent”) under that (i) certain Second Lien Trademark Security Agreement, dated as of December 15, 2017 (as amended, supplemented or modified and in effect from time to time, the “2017 Trademark Security Agreement”) by and among BESTCO LLC, a Delaware limited liability company (the “Grantor”) and the Administrative Agent and (ii) certain Second Lien Trademark Security Agreement, dated as of February 4, 2019 (as amended, supplemented or modified and in effect from time to time, the “2019 Trademark Security Agreement”) by and among the Grantor and the Administrative Agent (together with the 2014 Trademark Security Agreement, collectively the, “Trademark Security Agreement”). Except as otherwise provided herein, capitalized terms used herein but not otherwise defined have the meanings set forth (or incorporated) in the Trademark Security Agreement.

WHEREAS, pursuant to (i) the 2017 Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on December 18, 2017 at reel 6234, frame 0379 and (ii) the 2019 Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on February 5, 2019 at reel 6549, frame 0983, the Grantor granted to the Administrative Agent, for the benefit of the Lenders a Lien on and security interest in all of Grantor's right, title and interest in, to and under all of its Trademark Collateral, including, without limitation those set forth on the attached Schedule I;

WHEREAS, the Secured Obligations secured by the Trademark Collateral have been repaid; and

WHEREAS, the Grantor has requested and the Administrative Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its Lien on and security interest in the Trademark Collateral (the “Released Collateral”).

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its Lien on and security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in, and the security interest granted to the Administrative Agent in the Released Collateral.


