## **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of September 30, 2019 ("Release"), is made by John Hancock Life Insurance Company (U.S.A.), a Michigan corporation, as Collateral Agent ("Collateral Agent"), in favor of Shamrock Foods Company, an Arizona corporation ("Grantor").

**WHEREAS**, pursuant to that certain Amended and Restated Security Agreement dated as of April 13, 2017 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement") and the Amended and Restated Supplemental Security Agreement (Trademarks and Patents) dated as July 3, 2018 ("IP Security Agreement"), Grantor granted to the Collateral Agent a security interest in all of Grantor's right, title and interest in the IP Collateral (as defined in the IP Security Agreement); and

**SECTION 1. Defined Terms.** Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or IP Security Agreement.

**SECTION 2. Termination and Release.** Collateral Agent hereby:

- (a) terminates the IP Security Agreement;
- (b) terminates, cancels, forever discharges, and releases the security interest in all right, title, and interest in the IP Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto;
- (c) represents and warrants that it has full authority to execute and deliver this Release; and
- (d) authorizes the recordation of this Release with the USPTO at Grantor's expense.

**SECTION 3. Further Assurances.** Collateral Agent, upon Grantor's written request and at Grantor's expense, agrees to duly execute, acknowledge, procure and deliver any further reasonable documents and to do such other reasonable acts as may be reasonably requested by Grantor to the extent necessary to effect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to any of the IP Collateral, Collateral Agent will, upon Grantor's request and at Grantor's expense, execute and deliver a reasonable release of such IP Collateral or other reasonable instrument requested by Grantor that will terminate any such filing with respect to the IP Collateral and/or release any interest in the IP Collateral conveyed therein.
