## TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (hereinafter referred to as "Agreement"), is entered into as of the 9th day of December, 2019 by and between Dan Hershberg, an individual residing at 1406 S. Leithgow Terrace, Philadelphia, Pennsylvania 19147 (hereinafter "ASSIGNOR") and Workhorse Brewing Company, LLC, a Pennsylvania limited liability company with its principal place of business at 250 King Manor Drive, King of Prussia, Pennsylvania 19406 (hereinafter "ASSIGNEE").

WHEREAS, ASSIGNOR applied for and obtained and is currently the owner of the federal trademark registration listed on Schedule A, attached hereto and incorporated herein by this reference, and all other rights appurtenant thereto, including, but not limited to, the goodwill therein (hereinafter referred to as the "Trademark"); and

WHEREAS, ASSIGNEE desires to acquire all rights, title and interest that ASSIGNOR may have throughout the world in and to the Trademark and the application and registration thereof, along with the goodwill therein; and

WHEREAS, ASSIGNOR is willing to assign to ASSIGNEE all rights, title, interest and obligations ASSIGNOR may possess in and to the Trademark and the application and registration thereof.


NOW THEREFORE, in exchange for the amount of one dollar (\$1.00) paid by ASSIGNEE to ASSIGNOR, and other good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby assigns, conveys and sells to ASSIGNEE all rights, title and interest as ASSIGNOR may possess in and to the Trademark, including, without limitation (a) ownership in Trademark and the United States Registration thereof, together with the goodwill symbolized by said Trademark; (b) all income, royalties, profits and damages related thereto; (c) the right to register, prosecute, maintain and defend the Trademark before any public or private agency or registrar; and (d) the right to bring actions, defend against or otherwise recover damages or other compensation for past, present or future infringements, dilutions, misappropriations or other violations related to the Trademark including the right to sue and obtain equitable relief in respect of such infringements, dilutions and misappropriations of the Trademark; and

ASSIGNOR agrees to execute and deliver all papers, instruments, and assignments, and to perform any other reasonable acts the ASSIGNEE may require in order to vest all ASSIGNOR'S rights, title, and interest in and to the Trademark to the ASSIGNEE, and/or provide evidence to support any of the foregoing in the event such evidence is necessary to effectuate the assignment, to the extent such evidence is in possession or control of the ASSIGNOR.






