**CERTIFICATE OF MERGER OF  
LONZA INC. WITH AND INTO  
LONZA, LLC**

**Under Section 1003 of the Limited Liability Company Law**

Pursuant to Section 1003 of the Limited Liability Company Law of New York (the "Limited Liability Company Law") and Title 18, Section 209 of the Delaware Limited Liability Company Act (the "DLLCA"), each of the undersigned hereby certifies on behalf of the constituent entities named herein, as follows:

1. The name of each constituent entity is Lonza Inc., a New York corporation, and Lonza, LLC, a Delaware limited liability company. The name under which Lonza Inc. was formed is "Baird Chemical Industries, Incorporated."
2. The date when the Certificate of Incorporation of Lonza Inc. was filed with the New York Department of State is February 27, 1958.
3. The date when the Certificate of Formation of Lonza, LLC was filed with the Delaware Department of State is August 19, 2019. Lonza, LLC has not filed an application of authority with the New York Department of State and acknowledges that it is not to do business in the State of New York until such application is filed.
4. The merger has been approved and executed by Lonza Inc. and Lonza, LLC.
5. The name of the surviving constituent entity is Lonza, LLC, a Delaware limited liability company.
6. The merger is to become effective upon the acceptance of the filing of this Certificate of Merger.
7. Lonza, LLC, as the surviving foreign constituent entity to the merger, may be served with process in this state in any action or special proceeding for the enforcement of any liability or obligation of any domestic limited liability company, domestic business corporation or domestic other business entity previously amenable to suit in this state that is to merge and for the enforcement that is provided in the Limited Liability Company Law of the right of members of any domestic limited liability company, shareholders of any domestic business corporation or owners of any domestic other business entity to receive payment for their interests against the surviving foreign limited liability company.
8. Pursuant to Section 623 of the Business Corporation Law, Section 1005 of the Limited Liability Company Law or any applicable statute, Lonza, LLC will promptly pay to the shareholders of Lonza Inc. the amount, if any, to which they shall be entitled under the provisions of the Business Corporation Law, Limited Liability Company Law and any

applicable statute relating to the right of shareholders, members and owners to receive payment for their interest.

9. The Secretary of State is designated as agent of Lonza, LLC upon whom process against it may be served. The Secretary of State of the State of New York shall mail a copy of any such process to Lonza, LLC, as the surviving foreign constituent entity, at 412 Mt. Kemble Avenue, Suite 200S, Morristown, NJ 07960.

10. This merger is permitted by the jurisdiction of incorporation or organization for each foreign other business entity and foreign limited liability company and is in compliance therewith.

11. The agreement and plan of merger is on file at 412 Mt. Kemble Avenue, Suite 200S, Morristown, NJ 07960, which is the place of business of the surviving constituent entity.

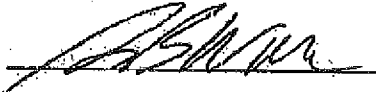
