TI Acquisition Corp. (the "*Company*"), a corporation incorporated and existing under and by virtue of the General Corporation Law of the State of Delaware, DOES HEREBY CERTIFY:

1. That the Company was formed under the name of Whamcloud 2, Inc. by filing its original certificate of incorporation with the Delaware Secretary of State on May 16, 2018, and on July 11, 2018, the Company filed a certificate of amendment with the Delaware Secretary of State changing its name to TI Acquisition Corp. (as amended, the "*Certificate of Incorporation*").
2. That article FIRST of the Company's Certificate of Incorporation is hereby amended and restated in full to read as follows:  
  
"FIRST        The name of the corporation is TINTRI BY DDN, INC."
3. That the foregoing amendment has been duly adopted in accordance with the provisions of Section 242 of the Delaware General Corporation Law, by approval of the board of directors of the Company by unanimous written consent on December 7, 2018.

The foregoing amendment shall be effective as of the date and time of filing.
