## TRADEMARK ASSIGNMENT

**THIS TRADEMARK ASSIGNMENT** (this “Assignment”), effective as of September 26, 2019 (the “Effective Date”) is made between Atlantic Capital Bancshares, Inc., a Georgia corporation (“Assignor”), and Atlantic Capital Bank, N.A., a federally chartered national bank (“Assignee”).

**WHEREAS** Assignor is the owner of the marks/names identified on Schedule “A” attached hereto (the “Marks”) and desires to assign to Assignee, all right, title and interest in and to: (i) any and all trademark and other intellectual property rights, including rights of priority, and the trademark registrations for the Marks; and (ii) any and all goodwill of the business associated with the Marks; and

**WHEREAS** Assignee desires to acquire the Marks and any and all goodwill of the business associated therewith from Assignor, subject to the terms and conditions of this Assignment; and

**WHEREAS** Assignor and Assignee desire to confirm of record the assignment of the Marks and goodwill to Assignee;

**NOW, THEREFORE**, in consideration of the foregoing recitals, the mutual covenants and conditions contained herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee hereby agree as follows:



Assignor hereby assigns to Assignee *nunc pro tunc* and effective fully as of September 26, 2019, all right, title and interest in and to the Marks, together with: (i) the goodwill symbolized by the Marks; (ii) all causes of action, claims and demands and other rights for or arising from any infringement or misappropriation of the Marks, including past infringements and misappropriations; and (iii) any royalties or other consideration owed in connection with use of the Marks after the Effective Date.
2. Assignor further agrees without further consideration to cause to be performed such other lawful acts and to be executed such further assignments and other lawful documents as Assignee may from time to time reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the registered owner of the Marks, goodwill and all other rights hereby conveyed.
3. Subject to the terms hereof, Assignee accepts such assignment of the Marks and goodwill.
