## RELEASE OF TRADEMARK COLLATERAL AGREEMENT

THIS RELEASE OF TRADEMARK COLLATERAL AGREEMENT (“Release”), dated as of December 18, 2019 is made by **FIFTH THIRD BANK, NATIONAL ASSOCIATION** (formerly known as Fifth Third Bank), acting as administrative agent hereunder for the Secured Creditors, and its successors and assigns (collectively, “Administrative Agent”), and is as follows:

WHEREAS, JENSEN STONE ACQUISITION COMPANY, L.L.C., a Louisiana limited liability company (“Debtor”), and Administrative Agent are parties to that certain Trademark Collateral Agreement, dated January 27, 2017, which was recorded with the United States Patent and Trademark Office on January 30, 2017 in its records at Reel 5976, Frame 0433 (the “Agreement”); capitalized terms used but not defined herein will have the meaning given to them in the Agreement;

WHEREAS, the Agreement granted to the Administrative Agent a security interest in all of each Debtor’s right, title and interest in and to all of its trademark collateral (collectively, the “Trademark Collateral”), including, without limitation: (a) each trademark, trademark registration, and trademark application listed on Schedule A of the Agreement (attached hereto and made a part hereof as Schedule I) and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application; and (b) all proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration, or trademark application listed on Schedule A of the Agreement or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages; and

WHEREAS, Administrative Agent desires to release its rights and security interests in the Trademark Collateral solely as granted under the Agreement solely as granted under the Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby fully and finally releases and terminates (i) its security interest and other rights in, to and under the Trademark Collateral and (ii) any and all other rights it may have under the Agreement.
