THIS IS TO CERTIFY THAT:

FIRST: The name of the Maryland corporation is Federal Resources Supply Company (the "Converting Corporation"), and the date of filing of the Converting Corporation's original articles of incorporation with the Secretary of State of Maryland is December 7, 1998. By virtue of these Articles of Conversion filed for record herewith, the Converting Corporation is converting (the "Conversion") to Federal Resources Supply Company, a corporation formed under the laws of the State of Delaware (the "Converted Corporation"), on the terms and conditions set forth herein.

SECOND: The terms and conditions of the Conversion were advised, authorized and approved by the Converting Corporation, in accordance with the provisions of Section 3-901 *et seq.* of the Maryland General Corporation Law ("MGCL") and in the manner and by the vote required by the MGCL and the articles of incorporation and bylaws of the Converting Corporation.

THIRD: At the effective time of the Conversion, each outstanding share of common stock of the Converting Corporation, par value \$1.00 per share (the "Converting Corporation Common Stock"), shall, without any action on the part of any stockholder of the Converting Corporation, be converted into and exchanged for one share of common stock of the Converted Corporation, par value \$0.001 per share. No shares of stock of the Converting Corporation of any class or series other than the Converting Corporation Common Stock are issued or outstanding.

FOURTH: The location of the principal office of the Converted Corporation in the State of Delaware is 2711 Centerville Road, Suite 400, Wilmington, Delaware 19808. The name and address of the resident agent of the Converted Corporation in the State of Maryland is CSC-Lawyers Incorporating Service, 7 St. Paul Street, Suite 820, Baltimore, Maryland 21202.




