TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment"), is made as of the _____ day of September, 2019 (the "Effective Date") by and between Wallmonkeys, LLC, a Maryland limited liability company ("Assignor") and Holmes Stamp Company, a Florida corporation ("Assignee").

Recitals

Assignor is the owner of the following trademark, which has been registered with the United States Patent and Trademark Office (the "USPTO"): "WALLMONKEYS", Registration No. 4,117,550 (the "Trademark").

The Trademark was originally owned by Wallmonkeys.com, LLC, an entity organized and existing under the State of New Jersey (the "Original Owner"). Pursuant to that certain Trademark Assignment, dated November 16, 2017 ("First Assignment"), and registered with the USPTO, the Original Owner assigned the Trademark to Assignor, but erroneously listed Assignor as "Wallmonkeys.com, LLC, a Maryland limited liability company." The reference to "Wallmonkeys.com, LLC" in the First Assignment was a scrivener's error, and should instead have referred to Wallmonkeys, LLC, a Maryland limited liability company.

Assignor desires to convey, transfer, assign, and deliver to Assignee the Trademark, and Assignee desires to accept such conveyance, transfer, assignment, and delivery, all in accordance with the terms and conditions set forth below.

NOW, THEREFORE, in exchange for Ten and No/100 Dollars (\$10.00) and other valuable consideration, the receipt of which is hereby acknowledged, the parties hereby agree as follows:

1. Assignor represents and warrants that the above recitals are true and correct.
2. Assignor hereby irrevocably conveys, transfers, assigns, delivers, and contributes to Assignee:
 - a. all of Assignor's right, title, and interest of whatever kind in and to the Trademark in the United States and all jurisdictions outside the United States;
 - b. all goodwill symbolized by the Trademark (including, without limitation, the right to renew any registrations included in the Trademark, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Trademark, and any priority right that may arise for the Trademark);
 - c. all rights to sue for and recover damages and profits based on any past, present or future infringement and/or dilution of any of Assignor's rights in or to the Trademark or injury to the goodwill associated with the Trademark, whether known or unknown, the same to be held and enjoyed by Assignee as fully and

entirely as said interest could have been held and enjoyed by Assignor had this sale, assignment, transfer and conveyance not been made; and

d. any and all rights associated with the foregoing.

3. Assignor irrevocably authorizes the officials at the USPTO to record the transfer of the Trademark to Assignee as assignee of Assignor's entire right, title, and interest therein.

4. Assignee shall file or cause to be filed with the USPTO all forms and applications necessary to evidence Assignor's conveyance of the Trademark to Assignee.

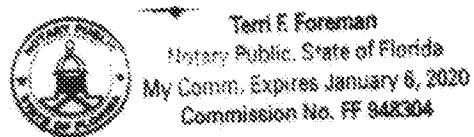
