TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of December 18, 2019 and made by **EUREKA RESTAURANT GROUP, LLC** (the "Grantor"), to **REEF CO, LLC**, a Delaware (the "Lender").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of April 18, 2017, made by Grantors in favor of Agent (the "Security Agreement"), a security interest was granted by the Grantors to Agent in certain collateral, including the Intellectual Property (as hereinafter defined);

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on April 24, 2017 at Reel/Frame 6040/0085.

WHEREAS, Agent now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Agent hereby states as follows:



2. Release of Security Interest. Agent hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Intellectual Property and reassigns to the person or persons legally entitled thereto all right, title and interest of Agent in the Intellectual Property.
