WHEREAS, Assignor agrees to assign to Assignee, and Assignee agrees to acquire from Assignor, all of Assignor's right, title, and interest in and to the Assigned Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Assignor and Assignee hereby agree as follows:

1. Conveyance and Acceptance of Assigned Trademarks. Assignor hereby sells, and irrevocably transfers and assigns to Assignee, and Assignee hereby accepts, all of such Assignor's right, title, and interest in and to the applicable Assigned Trademarks, including without limitation, the goodwill of the business connected with the use of and symbolized by the Assigned Trademarks, the right to sue and recover for past, present, or future infringements thereof, the right to secure and record registration of such Assigned Trademarks and of this Assignment, and the right to initiate other proceedings before the U.S. Patent and Trademark Office and all other corresponding entities or agencies in any applicable jurisdictions with respect to such Assigned Trademarks.

2. Right to Convey. Assignor hereby covenants that it has full right to convey the entire interest herein assigned and that it has not executed, and will not execute, any agreement in conflict herewith.

3. Recordation. Assignor hereby authorizes and requests that the U.S. Patent and Trademark Office and all other corresponding entities or agencies in any applicable jurisdictions record this Assignment. Assignor will take any and all reasonable actions, including without limitation, the execution, acknowledgment, and delivery of any and all documents that Assignee may reasonably request to record and perfect Assignee's, ownership of title and interest in and to its Assigned Trademarks or to clear any encumbrances with respect to the Assigned Trademarks.


4. Governing Law. This Assignment shall in all respects be governed by, and construed in accordance with, the Laws (excluding conflict of laws rules and principles) of the State of New York applicable to agreements made and to be performed entirely within such State, including all matters of construction, validity, and performance.

5. Counterparts. This Assignment may be executed in any number of counterparts with the same effect as if all signatory parties had signed the same document. All counterparts shall be construed together and shall constitute one and the same instrument.




